## **General Liability**

- I understand that due to the nature of pet grooming and pet care all quoted prices prior to grooming and/ or caring for my pet are only estimates. Final price will depend on the temperament of each pet and the condition of its coat. Upon physical inspection of my pet by the groomer a good faith estimated price will be provided. Extra charges may apply for pets that are matted and/or difficult to manage.
- I understand that I am liable for any medical or veterinary care expenses and damages that result from
  injuries caused by my pet. If my pet were to cause injuries or damages to an employee or patron
  (human or animal) of Dog Daze / 2813821 Ontario Inc., I recognize that I am liable and responsible for
  covering all related legal and medical expenses.
- If owner's dog is hurt or becomes ill I hear by grant permission to Dog Daze / 2813821 Ontario Inc. to
  obtain immediate medical care from a veterinarian of choice. I authorize Dog Daze / 2813821 Ontario
  Inc. to do whatever is necessary for the safety, health and well being of my pet. Further I (the dog
  owner/ owner's representative) assume full financial responsibility for any and all expenses incurred,
  unless illness or injury is clearly a direct result of negligence of the Dog Daze / 2813821 Ontario Inc.
  employees.
- At Dog Daze / 2813821 Ontario Inc. all dogs are treated by our employees with the utmost care and caution. Our employees will not be held responsible for clipper burn and /or minor nicks resulting from grooming of matted, pelted, neglected coats or for irritation caused by bathing or removing coat from dog possessing mild to severe skin allergies.
- I also realize that senior dogs have greater risk of injury resulting from grooming or care services and I will not hold Dog Daze / 2813821 Ontario Inc. responsible, nor will I hold them responsible for the stressful effects grooming or care services may have on my dog.
- Dog Daze / 2813821 Ontario Inc. must be notified within 24 hours of any claims by owner regarding compensation for medical attention given as a result of alleged negligence of our staff. In the event of dispute over owner's claim; Dog Daze / 2813821 Ontario Inc. will personally consult the attending veterinarian prior to settling any claim.
- Dog Daze / 2813821 Ontario Inc. will not be responsible for any allergic reactions resulting from the
  manufacturer recommended usage of any products. We take great care in selecting the best products,
  however we may encounter situations with unintended and/ or unexpected reactions. In saying this,
  your dog may have a reaction. If this should occur, we recommend consulting a veterinarian and
  informing us of your pet's reaction prior to your next appointment.
- Dog Daze / 2813821 Ontario Inc. is not responsible for pre-existing medical conditions or the
  aggravation of those conditions; such as but not limited to: heart disease, arthritis, obesity, infections,
  infestations, or any other medical problem that may be affected by the grooming process, or any of our
  services.
- Dog Daze / 2813821 Ontario Inc. reserves the right to charge additional fees for services we consider
  over and above the norm covered by our standard rates. We also reserve the right to refuse service to
  customers and pets who pose a threat to our employees and other pets in our care, whether it is an
  aggression problem, health problem, or viral or parasite problem.
- Should the owner's dog expose the unit or salon to parasites the groom will stop, the pet(s) will be
  isolated and the owner called for immediate pick up for veterinary treatment. There will be an additional
  \$150 charge to cover the expense for fumigation of the premises. It is necessary to fumigate to prevent
  contamination to other pets in our care.
- When a dog is matted/pelted and requires a shave down, some pre-existing conditions may be found which we will attempt to notify you of. In order to remove the matts/pelts the groomer must get under

the matt/pelt with the clippers and may cause some skin irritations, burns, knicks, cuts. There will be an extra charge for this service as the groomer required extra tools, blades, lubricant for clippers, and time to slowly and carefully remove the matts/pelts with the least amount of irritation possible.

- I, the undersigned, owner or person representing the owner, do hereby release Dog Daze / 2813821
   Ontario Inc. from any and all legal or medical responsibility resulting in stripping my dog and support the conditions stated in this agreement.
- Right to Refuse Service: Dog Daze / 2813821 Ontario Inc. has the right to refuse service for any reason it deems. In the event of a dog that cannot be groomed or cared for safely without danger to the groomer/employees, pets in our care, or others. Dog Daze / 2813821 Ontario Inc. will use muzzles, loops, harnesses, straps etc. on dogs when and if necessary. At times, groomers and attendants may have to use physical strength to restrain pets for safe and efficient grooming. Grooming and pet care services may be stopped immediately if necessary for the safety of the pet, groomer, attendant, or others. Grooming and pet care fees may still be applied.
- Duty to disclose: I have disclosed and will continue to disclose on an ongoing basis any and all medical, behaviour or other conditions or personality changes that may affect, limit or prevent my dog's ability to be groomed at Dog Daze / 2813821 Ontario Inc.
- I authorize Dog Daze / 2813821 Ontario Inc. to use photos of my dog for which I have legal ownership
  for any promotional materials regarding Dog Daze / 2813821 Ontario Inc. programs, facilities, or
  services. Promotional material bearing these photos may be distributed for free to the public and posted
  on the Dog Daze / 2813821 Ontario Inc. website and social media. Dog Daze / 2813821 Ontario Inc.
  reserves the right to use any photo or likeness for a time period beginning when this form is signed and
  ending upon written request of participant, or legal pet's owner.
- I hereby agree to expressly and forever generally waive, discharge claims, indemnify, release liability, save, hold harmless and defend Dog Daze / 2813821 Ontario Inc., their invitees, sponsors, advertisers, owners, employees, volunteers, agents, representatives, leasers and all others having interest in Dog Daze / 2813821 Ontario Inc. from and against any and all injury, liability, claims, litigation, actions, suits, costs, losses, damages, attorney's fees, expenses or demands of every character whatsoever on the account of, arising out of, resulting from or relating in any way to (1) any act or omission of the releases, including negligence, and (2) me or my pets participation at Dog Daze / 2813821 Ontario Inc., or otherwise. I agree that this release shall be binding on me and my successors, heirs, legal representatives and assigns. I also expressly and forever release Dog Daze / 2813821 Ontario Inc. from any duty to protect me, my representatives, or my dog's from injury of any kind, and agree that even if Dog Daze / 2813821 Ontario Inc. chooses to implement safety precautions; such actions shall not alter the fact that I have released Dog Daze / 2813821 Ontario Inc. from any duty to protect me, my representatives, or my dog.
- I have read and fully understand the terms of this form and that I have given up substantial rights by signing it and have signed freely and voluntarily without any inducement, assurance or guarantee and intend it to be a complete and unconditional release of liability to the greatest extent permitted by the law and agree that if any portion of this agreement is held to be invalid or unenforceable, the remainder of this agreement shall remain in full force and effect. I agree that it is intended that all terms of this agreement control despite any particular statute or law that would otherwise protect me or my pet.
